

2023 Doggie Depot Contest

OFFICIAL RULES

ALL PHOTOS SUBMITTED MAY APPEAR IN PHOTO GALLERY ON THE UNION DEPOT DOGGIE DEPOT LANDING PAGE AT UNIONDEPOT.ORG.

1. HOW TO ENTER: NO PURCHASE NECESSARY. In order to enter the 2023 Doggie Depot Contest (the "Sweepstakes"), from 9:00:00 a.m. Central Time ("CT") on December 21, 2022 through 11:59:59 p.m. CT on January 11, 2023 ("Submission Period"), go to the Union Depot Doggie Depot page at www.UnionDepot.org/DoggieDepot ("Website Page"), , complete the entry form, which includes your name, email address, phone number, along with your dog's name, gender, age, and breed, along with a space to upload a photo of the dog (required), and a brief explanation telling us why your dog should be the next Canine King or Queen of Doggie Depot (30 words or less). Then, you must agree to the Sweepstakes winner requirements in order to have a valid entry, agreeing that if the entrant is deemed the winner, they will attend the 2023 Doggie Depot event on January 28, 2023 from 1:30PM to 4:00PM at the St. Paul Winter Carnival Parade in St. Paul; and also the 2023 Doggie Depot Event on February 4, 2023 from 11:00 AM CT – 12:00 PM CT at Union Depot for the Coronation Ceremony. **Entries must be for ONE (1) dog only.** The entry form and photo submission collectively will hereinafter be referred to as the "Submission." Photos must only include **one (1) dog** in the photo; no collages will be accepted; no text added or logos permitted on the photos, or the entry may be disqualified, at Sponsor's sole discretion. If the photo you submit is not a photo of your dog, you must have the permission of the owner of the dog who appears in the photo before entering the dog's photo in this Sweepstakes. By submitting a photo you hereby represent and warrant that you took the photo yourself, or have express permission or a license to use the photo you submitted. Sponsor is not responsible for problems accessing web page or completing the entry or uploading a photo, or for technical or atmospheric conditions that disrupt the completion of the entry or uploading of the photo, or any other problems which might or might not result from this promotion. **Limit one (1) entry/dog per person/email address/household.** Any person submitting more than one (1) Submission, or a Submission without a photo attached, or not in compliance with the official rules may be disqualified, at Sponsor's sole discretion. The Submissions will then be divided into one (1) of two (2) groups based on the gender of the dog (individually, "Group" or collectively, "Groups"). The male dog Group will hereinafter be referred to as the "Boy Group," and the female dog Group will hereinafter be referred to as the "Girl Group."

This Sweepstakes is not sponsored, endorsed, administered by or associated with Facebook. By entering, you are providing your information to Sponsor and not to Facebook.

2. HOW THE WINNERS ARE CHOSEN: Members of the public who are 13 years of age or older can visit the Doggie Depot landing Page from 9:00:00 CT AM on January 12, 2023 through 11:59:59 PM CT on January 22, 2023, to vote up to **one (1) time per day** for his/her favorite dog per group (one vote for the Girl Group and one vote for the Boy Group). Sponsors are not responsible for votes not received or for other difficulties with the voting system due to difficulty accessing the internet, service outages or delay, computer difficulties or malfunctions, or other technological problems. Votes generated

by script, macro or other automated means will be disqualified. No one may offer to sell votes (or offer to be paid, whether in currency, in kind or other form of compensation, for votes). The use of automated or third party software or website to participate in the Public Voting is prohibited. Sponsor in its sole discretion reserves the right to disqualify any votes cast in violation of the above restrictions. The top scoring Boy Group and the top scoring Girl Group will each be deemed the Grand Prize winners. The Grand Prize winners will be featured on the Doggie Depot landing Page and the Union Depot Facebook Page at or about noon CT on January 23, 2023, and will be notified by email or telephone. In the event of a tie, a random drawing will be conducted from among all tying Submissions in the applicable Group to determine the winner.

3. **PRIZES:** There will be two (2) winners in this Sweepstakes (one (1) from the Girl Group and one (1) from the Boy Group). The winners will each receive a gift basket of pet-related goodies and gift cards valued at \$250. Tax Value to each winner: \$250.00.

A qualified winner must also meet the eligibility requirements as set forth in Paragraph 5 of these rules. The winner is responsible for paying all applicable income taxes. A 1099 form may be submitted to all appropriate taxing authorities, and by signing the Prize Release, each winner accepts the prize, and even if the winner does not use the prize/trip, he/she will be responsible for the applicable taxes.

4. **WINNER REQUIREMENTS & CLAIMING YOUR PRIZE:** The winners **must** attend and participate in the 2023 St. Paul Winter Carnival Parade on January 28, 2023 with their winning dog at a Sponsor-specified time. Additional, winners must claim their prize in person at Doggie Depot at Union Depot on **Saturday, February 4, 2023 from 11:00 AM CT – 12:00 PM CT with a short on-stage ceremony of Canine King and Queen.** Failure to comply with this deadline shall be deemed to be the winner's forfeiture of his or her right to claim the prize. The winners must prove he or she is a qualified winner by presenting identification acceptable to myTalk 107.1 (e.g., state drivers license; state issued identification card; valid passport with address verification; or birth certificate with social security card and photo identification and address verification). If the winner cannot prove he or she is a qualified winner, the prize shall be forfeited, and may be awarded to an alternate winner. All unclaimed prizes become the property of Sponsor.

No purchase necessary to enter the Sweepstakes.
